**ORDER**

Whereas, on the basis of the written examination conducted by Delhi Subordinate Services Selection Board Sh. Charanjeet Singh (Roll No. 69005724, D.O.B 19/06/1981, Employee ID-20172019) was provisionally selected & nominated for appointment to the post of Librarian vide Post Code 02/03 in Directorate of Education, Govt. of National Capital Territory of Delhi & his dossier was received in this Directorate through DSSSB vide letter No. 1(157)/DSSSB/P&P/2012/274-75 dated 29/03/2016.

Whereas, the documents verification & receipt of his medical fitness report from Deen Dayal Upadhyay Hospital, Govt. of NCT of Delhi Sh. Charanjeet Singh was appointed to the post of Librarian vide consolidate order No. 4/06/406/DRC/Lib./2016/3940-50 dated 27/09/2017 (Posting ID-20170159) and individual order No. 4/06/406/DRC/Lib./2016/3963-66 dated 29/09/2017 he was directed to join Libaspur-GBSSS-1309262 by 27/10/2017.

Whereas, as per his request an extension up to 15/12/2017 was granted vide order No. 4/06/406/DRC/Lib./2016/5730-35 dated 23/11/2017.


Whereas, as per Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training OM No. 35016/2/93-Estt. (D) dated 9<sup>th</sup> Aug. 1995 the extension can not be granted beyond six months. The OM is reiterated a under "*The matter has been examined in consultation with the UPSC and it has been decided to reduce from nine months to six months the maximum time upto which an offer of appointment can be kept to open. In other words an offer of appointment should be clearly specify the period (which shall not normally exceed one or two months) after which the offer would lapse automatically if the candidate did not join within the specified period. If however within the specified period, a request is received from the candidate for extension of time,*

*it may be considered by the Ministries/Depts. and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum of six months from the date of issue of the original offer of a appointment. An offer of appointment would lapse automatically after the expiry of six months from the date of issue of original offer of appointment.*

Whereas, Sh. Charanjeet Singh has not joined Libaspur-GBSSS-1309262 within the specified period and also not applied for extension.

Therefore, the appointment of Sh. Charanjeet Singh to the post of Librarian issued vide order consolidate order No. 4/06/406/DRC/Lib./2016/3940-50 dated 27/09/2017 (Posting ID-20170159) and individual order No. 4/06/406/DRC/Lib./2016/3963-66 dated 29/09/2017 are hereby cancelled.
