
ORDER

ORDER

The dossier of Ms. Parwati (Roll No.55002214) D.O.B. 09.10.1983 was received from DSSSB vide letter No. F.1(193)/DSSSB/P&P/13/Part File-II/226-28 dated 23.03.2017 nominating & recommending her for the post of TGT(Social Science under post code 13/13 category OBC. Accordingly after verification of her educational qualification & other documents and after declaring medically 'FIT' she was appointed to the post of TGT(Social Science) vide this office consolidated order DE.3(110)/E-III/DR/2017/1010-24 dated 06/07/2017 with the direction to report her place of posting latest by 28/07/2017.

But the candidate did not join her place of posting by 28/07/2017, however she was given extension for 60 days i.e. upto 26/09/2017 on her request. The candidate also has been appointed as PGT(Political Science) vide office order No.DE.2(8)(10)/E-II/DR PGT/Pol.SC./1603-1607 dated 10/08/2017 and she has joined at her place of posting as PGT on 11/08/2017. The request of the candidate was considered on merit and rejected by the competent authority.

ORDER
